AMPERS IS THE LARGEST ASSOCIATION OF COMMUNITY RADIO STATIONS IN THE STATE OF MINNESOTA AND THE LARGEST OF ITS KIND IN THE UNITED STATES. AMPERS CONSISTS OF 17 INDEPENDENTLY LICENSED AND MANAGED, LOCALLY RESPONSIVE, COMMUNITY-BASED RADIO STATIONS THAT SERVE BIPOC (BLACK, INDIGENOUS, PEOPLE OF COLOR), RURAL, AND STUDENT COMMUNITIES NOT TYPICALLY REACHED THROUGH TRADITIONAL MEDIA IN MINNESOTA. THE MAJORITY OF REVENUE AMPERS SECURES FOR ITS MEMBER STATIONS GOES DIRECTLY TO THE STATIONS. MOST OF THE FUNDS DO NOT FLOW THROUGH NOR DO THEY APPEAR IN THE ORGANIZATION'S FINANCIALS. IN ADDITION TO SECURING REVENUE FOR ITS MEMBER STATIONS, AMPERS PRODUCES PROGRAMMING. THE ORGANIZATION CREATES AND DISTRIBUTES "VETERANS' VOICES," A RADIO SERIES THAT ALLOWS (SEE SCHEDULE O)
